## PRIVACY STATEMENT FOR ELECTRONIC DATA

## **PURPOSE**

Blue Bird Body Company, along with its divisions, affiliates and subsidiaries (collectively "Blue Bird"), is sensitive to privacy issues relating to the exchange of electronic data and is committed to protecting your privacy on our websites. The protection of your privacy in the processing of your personal data is an important concern to which we pay special attention during our business processes. We will only disclose your data to governmental authorities in cases where it is required by law.

## **HOW TO UPDATE PERSONAL INFORMATION:**

Blue Bird requests that in order to maintain accuracy of the information, you can notify Blue Bird of any change to your mailing address, phone number or email address. All Blue Bird website pages, with the ability to collect personal information, also offer you the opportunity to remove your personal information from our email mailing list (upon request) at any time.
